LOMA WASTEWATER TREATMENT PLANT, said contract having been filed as Document No. 748599, in the office of the City Clerk be, and the same is hereby approved; and the changes therein set forth, amounting to a net increase in the contract price of \$20,908, be and the same is hereby approved.

BE IT FURTHER RESOLVED, that the expenditure of \$20,908 is hereby authorized out of Sewer Revenue Fund 506 of The City of San Diego, solely and exclusively, for the above purpose and related costs.
