

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, a grant agreement with the URBAN MASS TRANSPORTATION ADMINISTRATION (UMTA) in the amount of \$6,633,670 for the purchase of forty-five (45) 70-passenger articulated buses; associated fare collection and communications support equipment; assorted shop and office equipment; and five (5) road supervisor automobiles, under the terms and conditions set forth in the form of grant agreement on file in the office of the City Clerk as Document No. 752497.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to transfer the sum of \$63,178 from Public Transportation Reserve Fund 2571 to Transit System Purchase 45 Buses Fund 2578 to provide for payment of the one percent (1%) sales tax not eligible for Federal participation.
