WHEREAS, The City of San Diego is the owner of certain easements for sewer purposes affecting a portion of Lots 1, 2 and 4, Block 60 of City Heights according to the Map thereof No. 1007 filed in the Office of the County Recorder of San Diego County; and

WHEREAS, the value of the property right sought, as determined by a staff appraiser of said City, is the sum of Sixty-Five Dollars (\$65.00); and

WHEREAS, no real estate broker's commission shall be paid; and

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

- 1. That that certain real property right described in that form of quitclaim deed on file in the office of the City Clerk as 752582 Document No. , be, and the same is hereby authorized to be sold by negotiation for the sum of Sixty-Five Dollars (\$65.00) to SAN DIEGO TRUST AND SAVINGS BANK, as Trustee for P.T. 707.
- 2. That the Mayor and the City Clerk of said City be, and they are hereby authorized and empowered to execute, for and on behalf of The City of San Diego, a quitclaim deed, the form of which is on file in the office of the City Clerk as Document 752582 No. , quitclaiming to SAN DIEGO TRUST AND SAVINGS BANK, as Trustees for P.T. 707, those certain easements for sewer purposes affecting Lots 1, 2 and 4, Block 60 of City Heights, as more particularly described in said form of guitclaim deed.
- That no broker's commission shall be paid by City on the herein-described negotiated sale.
- That the City Clerk of said City is hereby authorized and directed to deliver said deed and a certified copy of this resolution to the Property Director for further handling.
