

RESOLUTION No. 214151Adopted on SEP 8 1975


BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that deed of LEROY MOORE, JR. and RUTH S. MOORE, husband and wife as joint tenants, executed in favor of The City of San Diego, bearing date of June 12, 1975, conveying to said City the permanent easement and right-of-way for an earth excavation or embankment slope or slopes and incidents thereto across a portion of Lot 5 in Block 12 of Silver Terrace, according to Map thereof No. 695, filed in the Office of the County Recorder of San Diego County, December 12, 1891, as more particularly described in said deed, be and the same is hereby approved.

That the expenditure of \$901 from Gas Tax Fund 220 is hereby authorized solely and exclusively to provide funds for acquisition of the above described property.

That the City Clerk is hereby authorized and directed to transmit said deed, after acceptance by the City Manager, and a certified copy of this resolution to the Property Director for further handling.
