


RESOLUTION No. 214154

That the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with SAN DIEGO STATE UNIVERSITY FOUNDATION, a nonprofit California corporation, to act as operational and fiscal agent for the operation of the San Diego Urban Observatory and provide the necessary and required services in connection therewith for the period July 1, 1975 through June 30, 1976, pursuant to the terms and conditions set forth in the form of agreement on file in the office of the City Clerk as Document No. 752571.
