


**RESOLUTION No. 214155**

That the City Manager be, and he is hereby authorized and empowered to execute, for and on behalf of said City an agreement with SAN DIEGO CITY AND COUNTY WAR AGAINST LITTER COMMITTEE, INC., to promulgate a program of Public Education designed to alert the people of San Diego to the problems of pollution, to the potential fire threat caused by litter, and to eliminate litter from our streets, highways, parks, schools and recreation areas, under the terms and conditions set forth in the form of agreement on file in the office of the City Clerk as Document No. 752597.
