That the City Manager be, and he is hereby authorized and empowered to submit, for and on behalf of the San Diego Police Department, to the California Office of Criminal Justice Planning, a grant award modification for the "ARJIS - City of San Diego" grant for the purpose of adding staff to design improved management information reporting systems for the Police Department, said grant modification is on file in the office of the City Clerk as Document No. 752605.

BE IT FURTHER RESOLVED, that upon award of said grant modification, the City Manager be further authorized to execute the necessary documents to accept the grant modification award.

BE IT FURTHER RESOLVED, that the amount of one thousand one hundred eleven dollars (\$1,111) be appropriated in the Fiscal Year 1976 Appropriation Ordinance for use in carrying out the grant modification program and to be used as the local matching funds which are required under the grant.
