WHEREAS, THE ANDERSON FOUNDATION, a charitable foundation, "Permittee," filed an application for an extension of time to Conditional Use Permit No. 391-PC; and

WHEREAS, on July 29, 1975, the Planning Commission voted 5 to 0 to approve the application for the extension of time; and

WHEREAS, on August 8, 1975, pursuant to the provisions of Section 101.0506 of the San Diego Municipal Code, the CITIZENS TO SAVE OPEN SPACE, by M. Eloise Battle, chairman, and Marian R. Bear, appealed the decision of the Planning Commission; and

WHEREAS, said appeal was set for public hearing on August 28, 1975, continued to September 4, 1975; and testimony having been heard, evidence having been submitted and the City Council having fully considered the matter and being fully advised concerning the same; and

WHEREAS, the City Council, in considering said appeal, is empowered by the provisions of Municipal Code, Section 101.0506, to affirm, reverse or modify in whole or in part any determination of the Planning Commission, subject to the limitations as are placed upon the Planning Commission by the Municipal Code; NOW, THEREFORE,
