RESOLUTION OF THE CITY COUNCIL OF THE CITY OF
SAN DIEGO DECLARING ITS INTENTION TO ORDER
CHANGES AND MODIFICATIONS IN THE DISTRICT
BOUNDARY UNDER RESOLUTION OF INTENTION NO. 211997
AS MODIFIED AND AMENDED BY RESOLUTION NO. 212617
IN THE MATTER OF THE IMPROVEMENT OF CAMINO RUIZ,
BLACK MOUNTAIN ROAD AND MIRA MESA BOULEVARD,
PURSUANT TO CHAPTER 8.5, DIVISION 7 OF THE
CALIFORNIA STREETS AND HIGHWAYS CODE.

WHEREAS, this City Council did, on November 14, 1974, adopt
its Resolution of Intention No. 211997 as modified and amended
by Resolution No. 212617 adopted February 13, 1975, all pursuant
to the Municipal Improvement Act of 1911 declaring its intention
to order the construction of certain improvements as more fully
described therein, and on the plans, profiles and drawings
therein referred to, and did provide for the cost of said work
to be assessed against the district described in said Resolution
of Intention; and

WHEREAS, subsequent to said public hearing, this Council
did order the improvements described in the above-referenced
Resolution of Intention; and

WHEREAS, the public interest, convenience and necessity
require that certain changes and modifications be made in the
district boundary proposed under said Resolution of Intention
as modified and amended and the territory to be included will
be benefited by the work proposed in said Resolution of
Intention as modified and amended; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

Section 1. That the public interest, convenience and necessity require and it is the intention of this Council to order the changes and modifications in the district boundary as more particularly described and shown on sheet 1-C of three (3) sheets of Plat No. 3880 filed in the office of the City Clerk as Document No. 752652, which is incorporated herein and which shall govern for all details thereof.

That no change in the cost of the work will result by reason of the aforesaid proposed changes or modifications in the district boundary.

Section 2. NOTICE IS HEREBY GIVEN, that on THURSDAY, OCT 9 1975, at 8:30 o'clock a.m. in the Council Chambers of the City Administration Building, Community Concourse, 202 C Street, in the City of San Diego, California, is hereby fixed as the time and place when and where any and all persons having any objections to the proposed changes and modifications herein proposed may appear and show cause why said changes and modifications should not be done and carried out in accordance with this Resolution of Intention to Modify.

Section 3. That the Clerk of said City be and he is hereby directed to cause this resolution to be published at least ten (10) days before the date of said hearing in the City's
