

RESOLUTION No. 214188Adopted on SEP 10 1975

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that deed of MORTY ZLOTOFF, a married man, and MILLIE ZLOTOFF, his wife, executed in favor of The City of San Diego, bearing date of July 21, 1975, conveying to said City the permanent easement and right of way for a public street and incidents thereto across a portion of Lot 9 and the unnamed street, closed and vacated to public use, of The Highlands, according to Map thereof No. 284, filed in the Office of the County Recorder of San Diego County, as more particularly described in said deed, be and the same is hereby approved; and the land therein conveyed is hereby dedicated as and for a public street and the same is hereby named KEARNY VILLA ROAD.

That the City Clerk is hereby authorized and directed to file said deed, after acceptance by the City Manager, and a certified copy of this resolution for record in the office of the Recorder of San Diego County.
