

RESOLUTION No. 214189Adopted on SEP 10 1975


BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that deed of SAMUEL WHITLEY and MARGIE R. WHITLEY, husband and wife as joint tenants, executed in favor of The City of San Diego, bearing date of July 3, 1975, conveying to said City for street purposes a portion of Lots 33 and 34 in Block E of Alta Vista Suburb according to Map thereof No. 1008, filed October 5, 1906 in the Office of the San Diego County Recorder, as more particularly described in said deed, be and the same is hereby approved; and the land therein conveyed is hereby dedicated as and for a public street and the same is hereby named 47TH STREET.

BE IT FURTHER RESOLVED, that the expenditure of \$900.00 from Gas Tax Fund 220 is hereby authorized solely and exclusively to provide funds for acquisition of the above described property.

BE IT FURTHER RESOLVED, that the City Clerk is hereby authorized and directed to transmit said deed and a certified copy of this resolution to the Property Director for further handling.
