

RESOLUTION No. 214190Adopted on SEP 10 1975

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that deed of UNIVERSITY OF SAN DIEGO, successor by merger to San Diego College for Women, executed in favor of The City of San Diego, bearing date of June 25, 1975, conveying to said City for park reserve purposes a portion of Pueblo Lots 267, 289, 292 and 293 of the Pueblo Lands of San Diego, according to Map thereof made by James Pascoe in 1870, a copy of said Map having been filed as Miscellaneous Map No. 36, on November 14, 1921 in the Office of the County Recorder of San Diego County, as more particularly described in said deed, be and the same is hereby approved.

That the City Clerk is hereby authorized and directed to transmit said deed, after acceptance by the City Manager, and a certified copy of this resolution to the Property Director for further handling.

BE IT FURTHER RESOLVED, that the expenditure of \$14,741.00 from San Diego Park District No. 12F, Fund 3713, is hereby authorized solely and exclusively to provide funds for acquisition of the above described property.
