BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that deed of GAYLORD H. GREEN, a widower, and LOTTIE J. JONES, a single woman, executed in favor of The City of San Diego, bearing date of July 10, 1975, conveying to said City for street purposes a portion of Lots 25, 26, 27 and 28 in Block E of Alta Vista Suburb according to Map thereof No. 1008 filed October 5, 1906, as more particularly described in said deed, be and the same is hereby approved; and the land therein conveyed is hereby dedicated as and for a public street and the same is hereby named 47TH STREET.

That the expenditure of \$1,800.00 from Gas Tax Fund 220 is hereby authorized solely and exclusively to provide funds for the acquisition of the above described property.

That the City Clerk is hereby authorized and directed to transmit said deed and a certified copy of this resolution to the Property Director for further handling.
