WHEREAS, on May 16, 1975, bids were opened for WEST MISSION BAY DRIVE BRIDGE LANDSCAPING in the City of San Diego, with Roderick W. Lloyd, an individual, dba Omega Landscape Co., as low bidder; and

WHEREAS, Omega delayed obtaining an Affirmative Action Certificate of Compliance for its listed subcontractor between the period of May 19 and June 23, 1975; and

WHEREAS, upon being advised by Omega on June 23, 1975 that there would be no subcontractor, the City of San Diego immediately released the project and awarded the contract thirty (30) days thereafter; and

WHEREAS, Omega has refused to enter into the contract as awarded in Resolution No. 213826, adopted on July 23, 1975; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

1. That Roderick W. Lloyd, an individual, dba Omega Landscape Co. be declared in default of the contract awarded by Resolution No. 213826, adopted on July 23, 1975.

2. That the bid of \$55,549.67 by Fritz A. Nachant, Inc., a corporation, for WEST MISSION BAY DRIVE BRIDGE LANDSCAPING, Base Bid and Additive Alternate, in the City of San Diego, California, is hereby accepted; and the City Manager is hereby authorized to execute a contract therefor in accordance with the form on file in the Office of the City Clerk as Document

That the expenditure of \$46,800.00 is hereby authorized from Park and Recreation Bond Funds (Fund No. 725) of the City of San Diego and that the expenditure of \$20,000.00 is hereby authorized from Gas Tax Funds (Fund No. 220) of the City of San Diego solely and exclusively for the purpose of providing funds for WEST MISSION BAY DRIVE BRIDGE LANDSCAPING, Base Bid and Additive Alternate, in the City of San Diego, and related costs.
