

RESOLUTION No. 214208Adopted on SEP 10 1975


BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that deed of LEADERSHIP HOUSING SYSTEMS, INC., a New York corporation, executed in favor of The City of San Diego, bearing date of July 2, 1975, conveying to said City for park purposes a portion of Lot 100, Miramar Ranch Unit No. 3, as more particularly described in said deed, be and the same is hereby approved.

That the expenditure of \$83,000 from Park Ordinance Fund 244 is hereby authorized solely and exclusively to provide funds for acquisition of the above described property.

That the City Clerk is hereby authorized and directed to transmit said deed, after acceptance by the City Manager, and a certified copy of this resolution to the Property Director of said City for further handling.
