WILLIAMS, INC., for the RESTORATION OF THE CALIFORNIA BUILDING - BALBOA PARK, said contract having been filed in the office of the City Clerk as Document No. 750450, be and the same is hereby approved; and the change therein set forth, amounting to an increase in the contract price of \$77,161, be and the same is hereby approved.

BE IT FURTHER RESOLVED, that the expenditure of \$77,161 is hereby authorized out of Capital Outlay Unallocated Reserve Fund 245 of The City of San Diego, solely and exclusively, for the restoration of the California Building in Balboa Park.
