WHEREAS, the City Attorney of The City of San Diego has expressed his concern about the environmental impact statement prepared by the United States Department of the Interior relating to the leasing of the Outer Continental Shelf; and

WHEREAS, several other cities and governmental entities have similarly expressed their concerns regarding that document; and

WHEREAS, these governmental entities now deem it necessary to seek a legal determination of their rights and obligations, and the rights and obligations of the Department of the Interior; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That the City Auditor and Comptroller be and he is hereby authorized to transfer the sum of \$500 within Fund 100 from the Unallocated Reserve (53.31) to the Allocated Reserve (53.20) for the sole and exclusive purpose of providing funds for expenses incurred in connection with said participation in the above proceedings.
