That the City Auditor and Comptroller be and he is hereby authorized to transfer the sum of \$500 within Fund 100 from the Unallocated Reserve (53.31) to the Allocated Reserve (53.20) for the sole and exclusive purpose of providing funds for expenses incurred in connection with said participation in the above proceedings.
