

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the expenditure of \$1,000 is hereby authorized out of Unallocated Reserve Fund 100 of The City of San Diego, solely and exclusively for the purpose of providing funds to the National League of Cities as the City of San Diego's contribution to help defray legal fees incurred by the League in connection with a suit filed by the National League of Cities against the United States Government challenging the constitutionality of those parts of the 1975 Amendments to the Fair Labor Standards Act (FLSA) which extend the coverage of the FLSA to State and municipal employees.
