RESOLUTION SETTING JUST AND REASONABLE  
FARES FOR THE HIRE OF TAXICABS WITHIN  
THE CITY OF SAN DIEGO PURSUANT TO SECTION  
72.02 OF THE SAN DIEGO MUNICIPAL CODE.

WHEREAS, Section 72.02 of the San Diego Municipal Code requires that the City Council shall, after hearing, set just and reasonable fares for the hire of taxicabs; and

WHEREAS, a public hearing was held by the Council on September 11, 1975, where evidence, testimony and opinions were given; NOW, THEREFORE,

BE IT RESOLVED, BY THE Council of The City of San Diego, as follows:

1. Just and reasonable fares for the hire of taxicabs within the City of San Diego shall be sixty cents (60¢) for the first one-sixth (1/6) mile and ten cents (10¢) for each additional one-sixth (1/6) mile or lesser fraction thereof. Waiting time shall be six dollars (\$6.00) per hour.

BE IT FURTHER RESOLVED that Resolution No. 210832, adopted June 13, 1974, be and it is hereby amended in paragraph E thereof to reflect the following formula to be utilized on determining the allowable taxicab flag drop rate:



68.4¢ through 75.9¢	\$0.75
