

RESOLUTION NO. 214244

WHEREAS, The City of San Diego is the owner of portions of Blocks 9 and 10, the Depot Grounds and former Iris Street and Kale Street, both closed and vacated to public use, all in Sorrento, according to Maps thereof No. 362 and 483 filed in the Office of the County Recorder of San Diego County; and

WHEREAS, the San Diego Gas & Electric Company, a corporation, has requested the conveyance of an easement for power line purposes over and across said property to establish a right-of-way to serve a proposed subdivision; and

WHEREAS, the purposes for which the easement is required are public purposes; and

WHEREAS, this action is exempt from the provisions of the California Environmental Quality Act of 1970 under City guidelines for implementation of said Act, as amended; and

WHEREAS, Section 22.0907 of the San Diego Municipal Code authorizes the conveyance of City property to public agencies for public purposes without complying with the provisions relating to the advertising for bids and auction sales contained in the Municipal Code; and

WHEREAS, the City Manager, pursuant to Section 22.0907 of the San Diego Municipal Code, has recommended that said easement be conveyed to the San Diego Gas & Electric Company, a corporation;
NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego,
as follows:



That, in consideration of the benefits to accrue to the people of said City, and the sum of \$120.00, the Mayor and the City Clerk of said City be, and they are hereby authorized and empowered to execute, for and on behalf of The City of San Diego, a deed conveying to the SAN DIEGO GAS & ELECTRIC COMPANY, a corporation, an easement for power line purposes over and across portions of Blocks 9 and 10, Depot Grounds and former Iris Street and Kale Street, both closed and vacated to public use, all in Sorrento, as more particularly described in the form of easement deed on file in the office of the City Clerk as Document No. 752718.

BE IT FURTHER RESOLVED, that the City Clerk is hereby authorized and directed to deliver said deed and a certified copy of this resolution to the Property Director of said City for further handling.
