A RESOLUTION DIRECTING THE CITY MANAGER IN COOPERATION WITH THE COMMUNITY RELATIONS BOARD TO CONDUCT A COST-EFFECTIVENESS ANALYSIS OF POLICE DEPARTMENT ACTIVITIES.

WHEREAS, the Public Services and Safety Committee conducted a hearing on August 27, 1975 in regard to a costeffectiveness analysis of Police Department activities; and

WHEREAS, said Committee unanimously agreed and recommends that a review of all pertinent information and an analysis of police activities be conducted by the City Manager in cooperation with the Community Relations Board with the objective that cost-effectiveness data be developed in regard to such activities and make recommendations thereon to the City Council; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

- 1. That the City Manager in cooperation with the Community Relations Board (herein called CRB) is hereby directed to review case histories and/or studies dealing with the relationship between numbers of police officers and crimes committed.
- 2. That should the results of the review so warrant, the City Manager in cooperation with the CRB shall be responsible for recommending to the Council, as alternate methods of reducing the incidence of crime and increasing the cost-effectiveness of police activities, an appropriate number of police officers for the City or, in the alternative, changes

WICROFILMED MAY 18 1978 in equipment, training, entry requirements, assignments, utilization of Police Reserves, programs or other applicable areas.

- 3. That the City Manager in cooperation with the CRB is hereby directed, in formulating said recommendations to the Council, be guided by the following directions and considerations:
 - (a) Solicit citizen opinion through community organizations regarding desired priorities among various police programs and indicate modifications to, or elimination of, programs as may be deemed appropriate.
 - (b) Contact and solicit opinions from various community organizations.
 - (c) In evaluating citizen input, determinations shall be guided not only by the perceived needs as expressed by the citizenry, but also by the Police Department's operational requirements and the City's budgetary constraints.
- 4. That the City Manager in cooperation with the CRB is hereby further directed to present progress reports to the Public Services and Safety Committee at least monthly.
