APPROVING MAP OF 100 SOUTH COAST SUBDIVISION

BE IT RESOLVED, by the Council of The City of San Diego,
as follows:

Said Council hereby finds that that certain map surveyed by W. R. NOTHOMB, Licensed Land Surveyor, and entitled "100 SOUTH COAST Being a subdivision of a portion of Lots 26 through 32, inclusive, in Block 1 of Nicholson's Addition, according to Map thereof No. 952, filed in the office of the County Recorder of San Diego County, June 21, 1905, together with that portion of the westerly half of Ocean View Street, also known as Vista Del Mar Avenue, vacated and closed to public use adjoining said lots on the east and Lots 1 through 5, inclusive, 26, and a portion of Lots 6, 7, 8, 23, 24, and 25, in Block 2 of Nicholson's Addition according to Map thereof No. 952, filed in the office of the County Recorder of San Diego County, June 21, 1905, together with that portion of the easterly half of Ocean View Street, also known as Vista Del Mar Avenue, vacated and closed to public use adjoining said lots on the west, being in the City of San Diego, County of San Diego, State of California.", is made in the manner and form required by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby

accepts on behalf of the public the following: 8 foot pedestrian way for beach access, and said pedestrian way is hereby declared to be a public right of way and dedicated to the public use.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map, and that said public right of way for pedestrian use is accepted on behalf of the public as heretofore stated.

The Clerk of said City is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
