

RESOLUTION NO. 214290

WHEREAS, The City of San Diego is the owner of portions of Pueblo Lots 1173 and 1182 in the City of San Diego; and

WHEREAS, said land was acquired as an easement for the extension of Murray Canyon Road and said portions of Lots 1173 and 1182 are surplus land; and

WHEREAS, when the easement was acquired by City, it was agreed, that the City would abandon portions of Old Murray Canyon Road within Pueblo Lots 1173 and 1182 except the portions falling within the new Murray Canyon Road alignment, to H. G. FENTON MATERIAL COMPANY, a corporation; and

WHEREAS, all the conditions of the agreement have been met; and

WHEREAS, said portions of Pueblo Lots 1173 and 1182 should now be quitclaimed to H. G. FENTON MATERIAL COMPANY, and the City Manager has recommended it; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That that certain real property described in that form of quitclaim deed on file in the office of the City Clerk as Document No. 752792, be, and the same is hereby authorized to be quitclaimed to H. G. FENTON MATERIAL COMPANY, a corporation.

2. That the Mayor and the City Clerk of said City be, and they are hereby authorized and empowered to execute, for and on behalf of The City of San Diego, a quitclaim deed, the form of

which is on file in the office of the City Clerk as Document No. 752792, quitclaiming to H. G. FENTON MATERIAL COMPANY, a corporation, portions of Pueblo Lots 1173 and 1182 of the Pueblo Lands of the City of San Diego, as more particularly described in said form of quitclaim deed.

3. That the City Clerk of said City is hereby authorized and directed to deliver said deed and a certified copy of this resolution to the Property Director for further handling.
