

RESOLUTION No. 214321Adopted on SEP 24 1975

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager is hereby authorized and empowered to execute, for and on behalf of said City, a Lease Agreement with the ASSOCIATED STUDENTS OF SAN DIEGO STATE UNIVERSITY, a California nonprofit corporation, and THE REGENTS OF THE UNIVERSITY OF CALIFORNIA, a California nonprofit corporation, for the purpose of renovation, operation and maintenance of an intercollegiate recreational and instructional waterfront facility in the southern boathouse located on Santa Clara Point, Mission Bay Park, valued at approximately \$432,100, for a term of 25 years, under the terms and conditions set forth in the form of lease agreement on file in the office of the City Clerk as Document No. 752832.
