BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be, and he is hereby authorized and empowered to execute, for and on behalf of said City, the necessary First Amendments to existing contracts which will continue ten (10) Human Care Services programs for the period from October 1, 1975 through October 31, 1975, and to execute a Second Amendment to the existing agreement with the Legal Aid Society of San Diego County, Inc., which will continue its program for said time period, said contracts to be funded with a total of \$68,238 in City Revenue Sharing Funds for Fiscal Year 1976 budgeted in Department 05.61 for this purpose. Said contracting agencies, programs, budget amounts and City Clerk document numbers on the forms of agreements are as follows:


