WHEREAS, the Auditor & Comptroller is of the opinion said Loren W. McCannon cannot be carried as a City employee after May 9, 1975 when he was relieved of his duties and has ordered said payroll to be corrected accordingly; and

WHEREAS, said Loren W. McCannon has filed a claim with The City of San Diego, a copy of which claim is attached hereto as "Exhibit A"; and

WHEREAS, a Director to succeed said Loren W. McCannon was not appointed until after May 23, 1975; and

WHEREAS, it is in the public interest that the understanding between the City Manager and said Loren W. McCannon that the latter was to be paid through the date of his resignation be ratified and said amount claimed to be due be authorized to be paid in consideration of his agreement to physically vacate his office and relinquish his authority and duties and in compensation for the inconvenience he was caused by having just relocated to San Diego from Long Beach only two months earlier; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

- 1. In consideration of the recitals set forth above, the claim of Loren W. McCannon, attached hereto as "Exhibit A," be and the same is hereby approved.
- 2. The sum of \$1,142.40 be and the same is hereby authorized to be paid to said Loren W. McCannon out of Fund 100 (Dept. 3910, Object Acct. 3295).



Re: Claim for Salary and Wages

Dear Sir:

I herewith submit a claim on the City of San Diego in the amount of \$1,142.40 for salary and wages owed to me but not paid.

On May 9, 1975, at a meeting attended by City Manager. Hugh McKinley, Assistant City Manager, Mike Graham and Deputy City Manager John Lockwood, I tendered my resignation as Director, Engineering and Development Department -- to be effective May 23, 1975, with the understanding by all parties that I would not be working during the said two week period--but that I would receive full pay.

I arranged for an associate to deposit my check on May 30th (for the pay period ending May 22, 1975). I was not advised until four days later that the check was for only one day. caused me much financial embarrassment, since I had written checks on the assumption that full payment would be made pursuant to the oral agreement.

Subsequently, there have been a number of telephone discussions with Deputy City Manager, John Lockwood and City Auditor, William Sage. The problem appears to be procedural. I can demonstrate from my calendar and by testimony of many associates in my former department that I had overtime well in excess of the two weeks time involved at my termination.

There is no question but that the City Manager's office wishes to live up to the oral agreement of May 9, 1975. However, the failure of the City of San Diego to pay me in accordance with that agreement has caused me great mental distress, financial embarrassment and considerable inconvenience.
