
BE IT RESOLVED, by the Council of The City of San Diego as follows:

R76-0397

1. That the offer of General Electric Company is hereby accepted and the City Manager is hereby authorized to execute a contract for the purchase of THREE (3) SATELLITE RECEIVERS, at a unit cost of \$1,138.75, and ONE (1) FIXED RECEIVER, at a cost of \$933.55, for a total cost of \$4,349.80, terms net 30 days plus sales tax.
2. That the expenditure of \$4,610.79 is hereby authorized from Capital Outlay Fund (Fund No. 245) of the City of San Diego, solely and exclusively for the purpose of providing funds for the purchase of THREE (3) SATELLITE RECEIVERS at a unit cost of \$1,138.75, and ONE (1) FIXED RECEIVER at a cost of \$933.55, and related costs.
