

RESOLUTION No. 214348Adopted on OCT 1 1975

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the agreement entered into between RUTH S. MATTEI and LEE E. MATTEI and THE CITY OF SAN DIEGO, a municipal corporation, filed in the office of the City Clerk as Document No. 745354, provided for the installation and completion of certain public improvements in ROY-AL UNIT NO. 1 subdivision, be amended to substitute Bond No. 1-776-654 for Exhibit C, in the amount of \$43,758.00, which bond has been executed by the subdivider, RUTH S. MATTEI and LEE E. MATTEI, as principal, and The Ohio Casualty Insurance Company, as surety for any sums due the State of California for the benefit of the Unemployment Insurance Fund to the extent that the State of California is interested, and for the benefit of the contractor, subcontractor and to persons renting equipment or furnishing labor or materials.

BE IT FURTHER RESOLVED, that Passbook No. 45-56588-4, in the total amount of \$43,758.00, issued by Central Federal Savings and Loan Association, Point Loma Branch, San Diego, CA, be, and it is hereby released.

BE IT FURTHER RESOLVED, that RUTH S. MATTEI and LEE E. MATTEI, subdivider of ROY-AL UNIT NO. 1 under that certain agreement made with The City of San Diego on file in the office of the City Clerk as Document No. 745354, are hereby granted an extension of time to November 1, 1976, within which to complete the improvements required by said agreement.
