


RESOLUTION No. 214354Adopted on OCT 1 1975

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of The City of San Diego, a Lease Agreement with JACOBS AND WEXLER PROPERTIES, whereby City leases 2,150 square feet of partitioned, air conditioned, carpeted and draped office space for use by the Community Relations Department, located at 2210 Fourth Avenue, for a yearly rental of \$7,901.25, under the terms and conditions set forth in the form of lease agreement on file in the office of the City Clerk as Document No. 752917.

BE IT FURTHER RESOLVED, that the expenditure of not to exceed \$7,901.25 from Fund 100, to be used exclusively for rental of the above described office space, is hereby authorized.
