

RESOLUTION NO. 214359

WHEREAS, the Police Department was authorized by Council Resolution No. 212084, dated November 21, 1974, to conduct a planning project to develop a method of analyzing one and two officer patrol strategies; and

WHEREAS, this project was the first phase of a study funded by a grant from the Police Foundation and has been conducted during the period commencing January 3, 1975 and scheduled to expire September 30, 1975; and

WHEREAS, authorization was extended at the beginning of the planning phase action in November of 1974 to conduct a phase two of the program in the event the planning phase one indicated such continuation was warranted; and

WHEREAS, based upon this first phase, the Police Foundation has indicated that a second phase grant is warranted and available in the sum of \$97,750 to implement a thirteen (13) month action grant which will conduct an analysis of the effectiveness of one and two officer patrol systems; and

WHEREAS, the thirteen (13) month grant for phase two is fully funded by the Police Foundation and does not require any local match by the City; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That the City Manager be and he is hereby authorized to accept and execute a thirteen (13) month action grant, including

any extensions or amendments thereto, from the POLICE FOUNDATION to the San Diego Police Department in the amount of \$97,750 for the purpose of conducting the second phase of an effectiveness study, fully funded by the Police Foundation, to analyze the effectiveness of one-officer and two-officer patrol cars, pursuant to grant agreement on file in the Office of the City Clerk as Document No. 752971.

BE IT FURTHER RESOLVED, that the City Manager be and he is hereby further authorized to execute agreements for contractual and consulting services as a continuation of those services provided during the first phase for the purpose of providing the project with specialized expertise as specified in the grant agreement, pursuant to the terms and conditions as set forth in the form of consultant agreements on file in the office of the City Clerk as Document No. 752980.
