WHEREAS, ROBERT W. CLACK and CHRISTINE CLACK, dba POWAY R. B. CAB COMPANY, have applied to the City Council for the reissuance of two limited certificates of public convenience and necessity to continue providing taxicab service in the Rancho Bernardo-Penasquitos area of the City; and

WHEREAS, pursuant to Section 72.01 of the San Diego Municipal Code, the City Manager has caused an investigation to be made and has reported his findings in writing to this Council, which report indicates:

(a) The service the applicants desire to perform is to continue providing taxicab service in the limited area of the City, outlined on the attached map. The business has been conducted in a highly satisfactory manner, and there is a continued demand for this service.

(b) Because this is a request to reissue two existing certificates of public convenience and necessity, no conflict with existing taxicabs, autos-for-hire, or bus service should occur.

(c) The applicants continue to be financially responsible and are experienced.

(d) The vehicles that are to be used are a 1971 five-passenger, 4-door Dodge Dart sedan and a 1966 five-passenger, 4-door Plymouth Fury II sedan; the color scheme of the vehicles is forest green and white.

(e) Being an existing business, no additional traffic congestion will occur.

(f) Being an existing business, this service will not result in a greater hazard to the public.

(g) The applicants personal and business references continue to check satisfactorily; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That Robert W. Clack and Christine Clack, dba Poway R. B. Cab Company, having filed an application for two limited certificates of public convenience and necessity to continue to operate taxicabs pursuant to the provisions of Section 72.01 of the San Diego Municipal Code, and the City Manager having conducted the required investigation, two limited certificates of public convenience and necessity are hereby granted to Robert W. Clack and Christine Clack to operate the vehicles specified in the application, limited to the pickup areas of Rancho Bernardo-Penasquitos as indicated on the attached map, subject to compliance with all provisions of the San Diego Municipal Code.

POWAY CAB CO.**

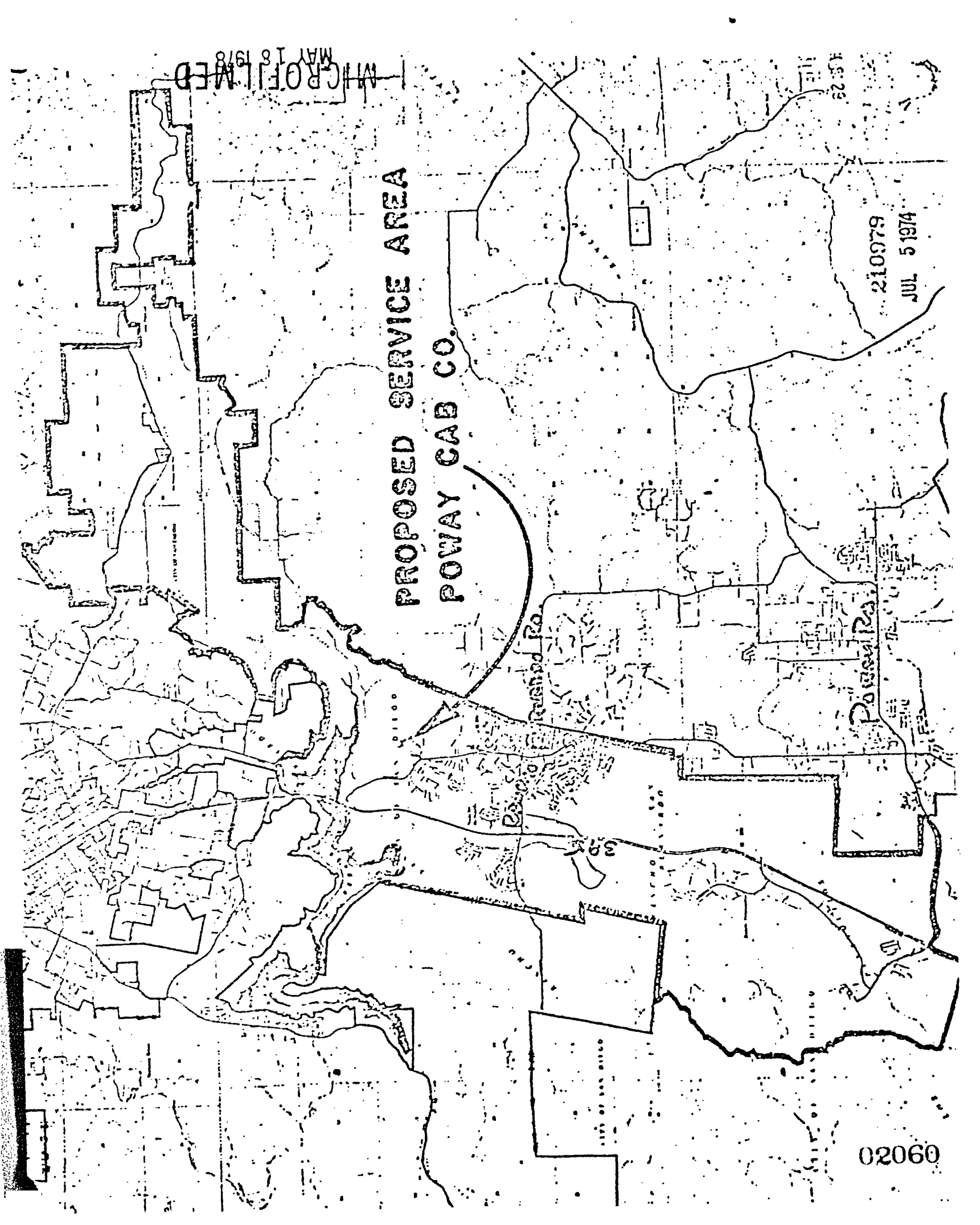
