
BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the bid of International Payline Branch is hereby accepted and the City Manager is hereby authorized to execute a contract for the purchase of THREE (3) TRACTOR BULLDOZERS for a cost of \$128,000.00 each; with a guaranteed maximum parts cost for 6,000 hours at \$21,000.00 each, guaranteed repurchase for 2,000 hours at \$79,644.00 each, or guaranteed repurchase at 6,000 hours for \$51,000.00 each; terms net 30 days, plus sales tax, less trade-in allowance of \$28,000.00.
