RESOLUTION AWARDING A CONTRACT TO IMPROVE THE ALLEYS IN BLOCKS 169, 180 AND 254, PACIFIC BEACH AND ALLEY IN BLOCK 2, NORTH SHORE HIGHLANDS.

WHEREAS, the Purchasing Agent of The City of San Diego, California, as authorized by City Council Resolution No. 183404, did on August 27, 1975 publicly open, examine and declare all sealed proposals or bids for doing the work and improvement described in Resolution of Intention No. 213518, which Resolution of Intention is hereby expressly referred to for description of said work and improvement, and for all particulars relative to the proceedings under said Resolution of Intention; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

at the prices named in the bid of said bidder on file in the office of the City Clerk.

2. That the City Clerk is hereby directed to cause notice of this award to be published twice in the City Official Newspaper and to record notice of this award in the office of the County Recorder as provided in Section 5248 of the Streets and Highways Code.
