RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SAN DIEGO, CALIFORNIA, ORDERING CERTAIN CHANGES AND MODIFICATIONS IN THE DISTRICT BOUNDARY UNDER RESOLUTION OF INTENTION NO. 211997 AS MODIFIED AND AMENDED BY RESOLUTION NO. 212617 IN THE MATTER OF THE IMPROVEMENT OF CAMINO RUIZ, BLACK MOUNTAIN ROAD AND MERA MESA BOULEVARD.

WHEREAS, this City Council did on November 14, 1974, adopt its Resolution of Intention No. 211997 as modified and amended by Resolution No. 212617 adopted February 13, 1975, declaring its intention to order the construction of certain improvements in the City of San Diego; and

WHEREAS, this City Council did on September 10, 1975, adopt its Resolution No. 214183 proposing to make certain changes and modifications in the district boundary as described in said Resolution of Intention; and

WHEREAS, the hearing has been held on said proposed changes, all in the manner and form prescribed by law, and objections not having been made by the owners of one-half of the area of the property proposed to be assessed, and this Council now having jurisdiction to make said changes and modifications; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That the public interest and convenience require certain changes and modifications in the district boundary for the assessment district originally set forth in Resolution of
