BE IT RESOLVED, by the Council of The City of San Diego as follows:

That The City of San Diego hereby accepts the generous donation of \$25,000 from Mr. Jerry Jameson to assist the City in the purchase and installation of playground equipment, the construction of play enclosures and related improvements at Chicano Park, Lomita Park, South Bay Community Park, San Ysidro Sports Field, Vista Terrace Park and other South and Southeast San Diego park and recreational facilities as may be appropriate.

BE IT FURTHER RESOLVED, that the expenditure of \$25,000 is hereby authorized out of Capital Outlay Fund 245 of The City of San Diego, solely and exclusively, as the City's share of the above-described improvement.

BE IT FURTHER RESOLVED, that this Council does hereby commend Mr. Jerry Jameson for this act of civic generosity and does hereby publicly express on behalf of the citizens of San Diego a debt of gratitude to him.
