

RESOLUTION No. 214458Adopted on OCT 15 1975


BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that deed of MARIA DE LOS ANGELES BALTHIER, an unmarried woman, executed in favor of The City of San Diego, bearing date of August 4, 1975, conveying to said a portion of Lots 41 and 42 in Block "D" in Alta Vista Suburb, according to Map thereof No. 1008 filed October 5, 1906 in the Office of the San Diego County Recorder, as more particularly described in said deed, be and the same is hereby approved; and the land therein conveyed is hereby dedicated as and for a public street and the same is hereby named 47TH STREET.

BE IT FURTHER RESOLVED, that the expenditure of not to exceed \$600.00 from Gas Tax Fund 220 is hereby authorized to provide for acquisition of the above described land.

BE IT FURTHER RESOLVED, that the City Clerk is hereby authorized and directed to transmit said deed, after acceptance by the City Manager, and a certified copy of this resolution to the Property Director for further handling.
