

RESOLUTION No. 214459Adopted on OCT 15 1975


BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that deed of ROSE VILLAESCUSA, executed in favor of The City of San Diego, bearing date of April 23, 1975, conveying to said City for street purposes a portion of Lots 57 and 58 of Sunshine Gardens, according to Map thereof No. 1804 filed August 27, 1924 in the Office of the San Diego County Recorder, as more particularly described in said deed, be and the same is hereby approved; and the land therein conveyed is hereby dedicated as and for a public street and the same is hereby named 47TH STREET.

BE IT FURTHER RESOLVED, that the expenditure of not to exceed \$2,050 from Gas Tax Fund 220 is hereby authorized for acquisition of the above described land.

BE IT FURTHER RESOLVED, that the City Clerk is hereby authorized and directed to deliver said deed, after acceptance by the City Manager, and a certified copy of this resolution to the Property Director for further handling.
