


**RESOLUTION No. 214460**Adopted on OCT 15 1975

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that deed of THE DIOCESE OF SAN DIEGO EDUCATION AND WELFARE CORPORATION, a corporation, executed in favor of The City of San Diego, bearing date of August 1, 1975, conveying to said City the easement for slope rights across a portion of Pueblo Lot 1177 of the Pueblo Lands of San Diego according to Map thereof made by James Pascoe in 1870, a copy of which said Map was filed in the Office of the County Recorder on November 14, 1921 and is known as Miscellaneous Map No. 36, as more particularly described in said deed, be and the same is hereby approved.

That the City Clerk is hereby authorized and directed to transmit said deed, after acceptance by the City Manager, and a certified copy of this resolution to the Property Director of said City for further handling.
