

RESOLUTION NO. 214470

RESOLUTION DECLARING A SURPLUS IN THE
CENTRE CITY WAY (1913 ACT) TRUST FUND 373
AND DIRECTING THE REFUND OF SAID SURPLUS.

WHEREAS, the City Council of The City of San Diego, did on the 30th day of December, 1970, confirm an assessment for the payment of the costs and expenses for certain improvements as contemplated by Resolution of Intention No. 201168 which Resolution of Intention is on file in the office of the City Clerk of said City; and

WHEREAS, the total costs and expenses of said assessment now appear to be less than originally determined at the time of the above Resolution of Intention; and

WHEREAS, the said Resolution of Intention provides that the total determined surplus shall be applied as a credit in the manner provided in Sections 10427.1 and 10427.2 of the California Streets and Highways Code; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That the work as contemplated by Resolution of Intention No. 201168 was estimated to cost \$929,482.39.
2. That the work of the above has now been completed and the total expenditures amount to \$919,028.70 leaving a surplus of \$10,453.69.

That pursuant to Section 10427.1 of the Streets and Highways Code, the above surplus is hereby applied as a credit to the assessment in the proportion which each individual assessment, or installment of principal thereof, bears to the total of all individual assessments in the assessment, and the City Treasurer is hereby directed to refund said surplus accordingly.
