


**RESOLUTION No. 214491**Adopted on OCT 15 1975

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That Franklin T. Hamilton, Attorney at Law, be employed and appointed as special bond counsel for giving an opinion on any bonds that may be issued to pay for the acquisition of approximately 5.337 acres in the Scripps Ranch area for HENDRIX PARK (SAN DIEGO PARK DISTRICT NO. 16) under the provisions of the Municipal Improvement Act of 1913 and the San Diego Park District Procedural Ordinance of 1969, pursuant to the terms and conditions set forth in the letter dated July 31, 1975, on file in the office of the City Clerk as Document No. 753072.

That in the event the proposed proceedings described above fail to materialize or are abandoned before an assessment has been levied and collected, the City shall not be liable for payment of any of the costs incurred in said employment.
