WHEREAS, the City Council appointed the District Attorney's office as enforcement agency for the City's Campaign Contribution and Expenditure Control Ordinance by Resolution No. 207968, adopted May 17, 1973; and


WHEREAS, budgetary restrictions have now imposed a severe limitation on the District Attorney's capability of performing said enforcement service for the City without reimbursement therefor; and

WHEREAS, it is desirable for the District Attorney to continue to act as the enforcement agency for the City in this regard; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That the City Auditor and Comptroller be and he is hereby authorized to expend from the Unallocated Reserve (53.31) the sum of \$32,994, payable to the San Diego County District Attorney's office, for the sole and exclusive purpose of reimbursing said agency for expenses incurred as a result of enforcing The City of San Diego's Campaign Contribution and Expenditure Control Ordinance, pursuant to Resolution No. 207968.
