RESOLUTION OF THE CITY COUNCIL OF THE CITY OF
SAN DIEGO, CALIFORNIA, ORDERING CHANGES AND
APPROVING PLANS AND PROFILES SHOWING THE CONTEM-
PLATED CHANGES AND MODIFICATIONS IN THE WORK
DESCRIBED IN RESOLUTION OF INTENTION NO. 214095
FOR THE IMPROVEMENT OF NOELL STREET.

WHEREAS, this City Council did on August 27, 1975, adopt Resolution of Intention No. 214095 and declare its intention to order the construction of certain improvements as more fully described therein and on the plans, profiles and drawings therein referred to, and did provide for the cost of certain work to be assessed against the district described in said Resolution of Intention; and

WHEREAS, during the course of the hearing on Resolution of Intention No. 214095, the Council determined that it was necessary to order certain changes in work, said changes not involving the inclusion of additional territory requiring additional notice or further hearing; and

WHEREAS, the public interest, convenience and necessity require that (1) certain changes and modifications be made in the proposed work to be done in said Resolution of Intention, and (2) that the work described in said Resolution of Intention be amended by deleting Robinson Avenue and Archer Street; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:
