1. That the bid of \$75,075.00 by R.E. Hazard Contracting Co., a corporation, for RECONSTRUCTION OF THE INTERSECTION OF FAY AVENUE AT NAUTILUS STREET AND TO INSTALL TRAFFIC SIGNALS AND SAFETY LIGHTING, INCLUDING OPTIONAL ALTERNATE "A", in the City of San Diego, California, is hereby accepted; and the City Manager is hereby authorized to execute a contract therefor in accordance with the form on file in the office of the City Clerk as Document No. 752509.
2. That the expenditure of \$105,000.00 is hereby authorized from Gas Tax Funds (Fund No. 220) and that the expenditure of \$20,777.00 is hereby authorized from Capital Outlay Fund (Fund No. 245) of the City of San Diego solely and exclusively for the purpose of providing funds for RECONSTRUCTION OF THE INTERSECTION OF FAY AVENUE AT NAUTILUS STREET AND TO INSTALL TRAFFIC SIGNALS AND SAFETY LIGHTING, INCLUDING OPTIONAL ALTERNATE "A", in the City of San Diego, and related costs.
