BE IT RESOLVED, by the Council of The City of San Diego as follows: R 76 - 0780

That the City Manager is hereby authorized and empowered to do by City forces all the work of relocating a fire hydrant, as required in connection with RECONSTRUCTION OF THE INTERSECTION OF FAY AVENUE AT NAUTILUS STREET AND TO INSTALL TRAFFIC SIGNALS AND SAFETY LIGHTING, INCLUDING OPTIONAL ALTERNATE "A", pursuant to recommendation of the City Manager and submission of estimates by him indicating that said work can be done by the City Forces more economically than if let by contract. The cost of said work shall not exceed \$2,070.00.
