


RESOLUTION No. 214533Adopted on OCT 29 1975

THOMAS, executed in favor of The City of San Diego, bearing date of September 15, 1975, conveying to said City a portion of Lot 19 of Moore's Subdivision according to Map thereof No. 1300 filed December 21, 1910 in the Office of the San Diego County Recorder, as more particularly described in said deed, be and the same is hereby approved; and the land therein conveyed is hereby dedicated as and for a public street and the same is hereby named PALM AVENUE.
