

RESOLUTION NO. 214553

WHEREAS, pursuant to Resolution No. 205781, adopted June 8, 1972, the City Council of The City of San Diego formally recognized various employee organizations to represent employees in appropriate units established in accordance with Section XII of the Employer-Employee Relations Policy; and

WHEREAS, new classifications created by salary ordinances adopted since May, 1973 have not been formally included in appropriate employee representation units nor have those classifications deleted by said salary ordinances been removed; and

WHEREAS, various title changes have occurred which have not been reflected in the listing of classifications represented; and

WHEREAS, it is now necessary to include newly adopted classifications in and remove deleted classifications from existing appropriate units as established by the City Council and change those classification titles as may be appropriate; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the classifications previously designated by the Council as appropriately assigned to employee representation units be and the same are hereby amended to reflect additions of new classes, removal of deleted classes, and corrections to changed
