BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be, and he is hereby authorized and empowered to execute, for and on behalf of said City, six (6) one-month contracts (November 1, 1975 to November 30, 1975) with Human Care Services Programs for a total authorized expenditure of \$41,031, and the City Manager and City Attorney are hereby directed to negotiate, prepare, and process new agreements for Council approval which would extend the six programs for the balance of Fiscal Year 1975-76.
