

RESOLUTION NO. 214572

Adopted on NOV 5 1975

WHEREAS, the Suggestion Awards Committee has heretofore made certain recommendations to this Council; and

WHEREAS, the Council has reviewed said recommendations as well as the suggestions as presented; NOW THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

Koivisto	PLANNING DEPARTMENT	\$545	These two Zoning Assistants became concerned with the substantial amount of time required to write sometimes voluminous information in regard to plans submitted for approval. This information then had to be typed on an original with three copies. The suggesters designed a three-part form having virtually every type of information involved on it and designated by number. As the information is obtained, the applicable number is simply circled, thus eliminating both the handwriting and subsequent typing. This results in a much needed saving of \$5,473 per year in personnel time.
Richard O. Morse	POLICE DEPARTMENT	\$220	Sgt. Morse observed that much of the property taken at the time of an arrest is not needed as evidence and is simply to be returned to the owner. The practice had been to later go through a property release procedure when time for release occurred. Sgt. Morse suggested that the arresting officer make out the release form when it is known the property is to be returned (this is known at the time of arrest). This eliminates a great deal of time and expense required when done later. The savings are estimated to be about \$2,223 per year.
