Nancy J. Lovell	GENERAL SERVICES Solid Waste Division	\$45	Ms. Lovell received a \$20 award for suggesting an improved filing procedure for personnel files some time ago. It has been found that there is an additional saving of \$450 worth of time per year resulting from this suggestion that was not included in the original estimate.
